Contract applications are due January 1, 2012. You will be notified of a decision after January 15, 2012. Contracts received after this date will be considered as space allows. A wait list will be established. This contract, signed by both the dealer and the Show Director, accompanied by table fee payment, is necessary to participate in the show. **Only cash, checks or money orders will be accepted for table fee payments.** At least one half of your total table fee must accompany this contract and the balance is due by June 1, 2012. Your table(s) must be paid in full by that date or your deposit and table will be forfeited. Dealer cancellations prior to June 1, 2012 will incur a \$50 processing fee. There are no refunds after June 1, 2012. **Dealers are required to stay a two night minimum at the Marriott Teaneck at Glenpointe.** Dealers are responsible for collecting and paying New Jersey State sales tax. If the show is canceled for any reason, the dealer will not hold IGMA or the Teaneck Marriott at Glenpointe Hotel responsible and waives any and all demands and claims for damages. The sole liability of IGMA shall be to return paid table fees to the dealer within thirty days. The exhibitor assumes the entire responsibility and liability for losses, damages, and claims arising out of exhibitor's activities on the Hotel premises and will indemnify, defend and hold harmless the Hotel, its owner, and its management company, as well as their respective agents, servants, and employees from any and all such losses, damages and claims. Additionally, it is expressly understood that IGMA, its committees and members shall not be held responsible for any loss or damage occasioned to the dealer's merchandise or equipment from whatever cause, or any personal injury to the dealer, his agents or employees from any cause.
